3. Annex E – Technical Requirements & Performance Specifications, Section 1.7 Coverage requirements for USF service quality commitments

Coverage of the townships shall be in accordance with the following requirements: a) Useable rural outdoor signal of minimum <u>-100dBm for 3G technology</u>, <u>-95dBm for 2G technology</u> and <u>-105dBm for 4G technology</u> to at least 80% of the population in the village tracts (VT) not already covered to this level.
